- Recipients must be good all-round students who have demonstrated good citizenship characteristics and service to their school and community.
- Financial need a consideration.

***CHAMBER OF COMMERCE – JESSIE BURGESS AWARD**

- To be presented to the most deserving CCHS grade 12 student, effective the year of their graduation.
- The recipient will be an all-round individual – active in athletics, drama, music, in or outside school, or other extracurricular activities.
- The recipient will achieve good academic standing however, honors standing is NOT a necessity.
- The recipient must NOT receive other CCHS awards during the school year, with the exception of honors.
- The recipient is NOT required to continue his or her schooling to receive this award.
- Financial need will be a consideration of the award.
- Applicants please provide some details about how you intend to finance your education and whether there are extenuating circumstances the Awards Committee should be aware of.

- Recipient must be graduating this year.
- Student must have made an outstanding contribution to programs of the school and/or community.
- Student must intend to pursue post-secondary study in teacher education and must have acceptance from post-secondary institution.

- Financial need will be a consideration.

- Recipient must be a full-time student at CCHS during the year of graduation and application.
- An average of 80% or higher on five 30 level courses required to enter the chosen area of study at university level.
- Extracurricular involvement in the school.
- Extracurricular involvement in the community.
- Must be attending post-secondary institution in the fall.

- Recipient must have honors standing.
- Recipient must have contributed to school and/or community.

ALICE THOM MEMORIAL SCHOLARSHIP

- Must be a grade 12 student at Camrose Composite High School.
- Recipient must be attending a post-secondary institution to pursue studies in fine art, art, drama or music in the fall term.
- Recipient will achieve honors standing at the 30 level in the area of focus – art, drama, or music and will achieve good overall academic standing.

CHARLIE AND HELEN McCLEARY ENDOWMENT FUND (2 awards)

- Recipient must be graduating this year.
- Student must intend to pursue post-secondary study in music or drama (must have taken at least one music class) OR student must intend to pursue post-secondary study in teacher education or English literature.

- Student must not have received another major award at CCHS.

- Preference given to an average student who has demonstrated service and leadership qualities.

- Letter of intent must accompany application.

- Recipients must be full time students at CCHS.

FOIP CONSENT - NOTICE OF ACTIVITIES



PARENT/GUARDIAN - PLEASE READ CAREFULLY

As required by the Freedom of Information and Protection of Privacy Act, Sections 33(c), 34 and 39

The purpose of this notice is to inform you about the collection and use of student information by the **Battle River School Division**. In many cases the information is specifically mandated under the Education Act, such as the information provided when a student is registered. For example, the Division must provide Alberta Education with specific information on each student. Certain information may also be required by Alberta Health Services or other Ministries. In other instances, personal information is collected and used for authorized programs and activities that are a normal part of school life. These uses, which are listed below, are a vital part of a healthy and functioning school and participation of all students is very important. We realize, however, that there may be occasions where you, as parents or guardians, have concerns relating to the safety of your child with any of these uses of information; if this is the case, contact the school office.

Types of activities where information may be collected or used include:

- student name / photos / comments in school calendar / newsletter / yearbook / other school publications;
- taking of individual / class / team photos and the use of student photos for purposes of identification;

- taking of photos / videos of classroom / other school activities, and their use or social media posting by the media or other organizations where students are not identifiable or interviewed. You will be contacted for permission prior to use.) Note that photos/videos/social media posts of school activities that are open to the general public may be taken and used for purposes within and outside of the school. The school may not be able to restrict such activity at public events;

(Where individual students are identified or interviewed and the material will be used outside the school division, a separate, specific consent will be required. You will be contacted for permission prior to use);
- student name / photos in listings of honor roll / grad / scholarship / other awards or birthday recognition;
- circulation of "need-to-know" information re: students who have severe / life-threatening medical conditions;
- parent/guardian name / phone numbers / mailing address / student name / student grade made available to School Council Executive (who represent the parents and engage in activities in support of the school) for contact purposes.
